# PROXY

In order to ensure that club business can be conducted in an effective and timely manner, SARG Club Members with voting status agree to assign their proxy to the SARG Club Officers in the event that they are not in attendance at a club meeting at which an official vote is to be held.

- In order to vote, a Club Member with voting status must attend the meeting at which an official vote is to be held, or reassign their proxy to another eligible Club Member that will be in attendance at that meeting.
- If a Club Member with voting status is not in attendance at a meeting at which an official vote is to be held, and has not reassign their proxy to another eligible Club Member that is in attendance at that meeting, the proxy of a Club Member not in attendance at that meeting will be assigned to the Club Officers.
- Club Officers will announce all official votes in accordance with club bylaws.
- Club Members with voting status will retain their proxy when they are in attendance at a club meeting at which an official vote is to be held.
- Club Members with voting status may revoke and reassign their proxy at any time.
- Revocation and Reassignment of Proxy must be received in writing by a Club Officer at least 7 days prior to an announced official vote.
- Revocation and Reassignment of Proxy will be for a period of no longer than 30 days.
